Road closure to through traffic shall be between the intersections of Jensen Road and Sycamore Road. The purpose of the road closure is to complete work associated with replacement of a cross road culvert near the Prentice Road intersection. Full access to all intersections and local businesses will be maintained, and traffic to local businesses may continue to use Old Vestal Road.
