**NOTICE TO BIDDERS**

NOTICE IS HEREBY GIVEN that sealed proposals are hereby sought by the Board of Fire Commissioners of the Town of Vestal Fire District, Town of Vestal New York on behalf of the Fire Department for the **Purchase One (1) New and Unused Mobile Water Supply Fire Apparatus.**

Bids shall be enclosed in a sealed, post-paid package marked “**Mobile Water Supply Fire Apparatus Tanker 32-2**” and addressed to Town of Vestal Clerk’s Office, [605 West Vestal Parkway, Vestal, New York 13850](#). Such bids shall be received in the Town Clerk’s Office until **June 28, 2016\*** at which time the bids will be opened and read aloud at the 2:00 PM.

Proposals must be made upon the bidder’s letterhead and signed by a duly authorized representative of the bidder.

No bidder may withdraw their bid within sixty (60) days after the date of opening, but may withdraw it any time prior to the scheduled closing time for reception of bids.

If mailing is requested, a separate check of \$10.00 (made payable to Town of Vestal) is required to cover postage and handling. Delivery via **Federal Express** can be arranged by contacting the Town Clerk’s Office at 607-748-1514 ext. 321 or 320 and providing your Federal Express account number and delivery preference.

The Town of Vestal Fire District reserves the right to hold all bids for a period of sixty (60) days after the opening of such bids submitted to check the qualifications of bidders and to obtain the necessary approvals, if any, of the division department of the State of New York as may be required by law.

The Vestal Board of Fire Commissioners shall have complete discretion to reject any bid that does not meet the required specifications or to reject all bids should the Board deem the same to be appropriate. The Board may waive any formalities or reject any and all bids and re-advertise for new bids at its discretion.
